Brief Course Description

This course will examine issues at the intersection of mental health care ethics and moral agency. In particular, we will consider whether and how impaired mental capacities might bear on questions concerning the moral agency and the ethical treatment of members of certain clinical populations, including psychopaths and individuals suffering from addiction. In exploring these issues, we will engage with bioethical approaches to understanding the nature and treatment of the aforementioned disorders and recent literature on agency and moral responsibility.

Students are expected to come to class having done the readings. All readings will be available to you online on the TritonEd course site. Note that readings marked "[REC]" are recommended and entirely optional. Regular attendance and preparedness for class are important. Attendance can impact your grade. You may miss one class with no penalty. Each unexcused absence after the first will result in your attendance grade being lowered by 10 points. The remaining portion of your grade will be determined by papers, as indicated below. Students are required both to hand in hard copies of their papers in class and to submit them electronically (papers will be checked for plagiarism). You may use laptops/tablets for note-taking only.
